On behalf of the members of the Swiss-American Business Council (SABC), the leading non-profit business association for the Swiss-American business community that represents tens of thousands of jobs, hundreds of millions of dollars in investment, and significant business ties in the U.S. Midwest and Switzerland centered in Chicago, we strongly urge you not to close the Consulate General of Switzerland in Chicago that provides official representation of Switzerland in this economic center. For economic efforts, the Consul General and his office is our strongest partner here in Chicago.

The Swiss-American relationship in the Midwest is of strategic importance both in terms of business and cultural ties, and the Consulate General of Switzerland provides crucial support to this vibrant community to maintain a strategically vital footprint in the region for the following reasons:

A Strong Swiss-Chicago Business Relationship is key to the Strategic Partnership

Over 100 Swiss companies have more than 450 locations in the Chicago area;

Chicago is currently the Midwest corporate headquarters for 17 of the Top 45 Largest Swiss companies in the world as well as numerous small and medium sized companies. Some of these companies with the largest presence in the Chicago area include: Zurich Financial, Novartis, Nestlé, Geberit, Schmolz & Bickenbach, and Roche Holdings;

More than 40 Chicago-area Fortune 100 companies have a significant presence in Switzerland, including Kraft, Boeing, McDonald's, Caterpillar, UL International, Motorola, Baxter International,

Abbott Laboratories, Wm Wrigley Jr. Co., Sirva, Inc. and Nalco Holding Company;

Many of these Fortune 100 Chicago area companies have recently re-located their European headquarters to Switzerland, including McDonald's (Geneva), Parker Hannifin (Etoy), Archer Daniel Midlands (Rolle), CF Industries Holdings, Inc. (Zurich), Grant Thornton International (Zurich), Takeda Pharmaceuticals (Lachen), Dover Corporation (Geneva), and Amsted Industries Incorporated (via Polyscience AG in Zug and Polygap in Geneva);

2011 total trade between Switzerland and the U.S. Customs District in Chicago amounts to

US\$4.22 billion primarily in the manufacturing industries:

35,000 Swiss-Americans in Illinois (based on the official 2010 Census);

The Chicago area includes some of the prominent American universities, such as the University of Chicago and Northwestern University, and top research institutions, such as Argonne National Laboratory and Fermilab, and remains a key destination for the Swiss research community that has built strong partnerships in the Midwest region, all of which provide an important path for maintaining innovation in Swiss industry.

The Lucerne-Chicago Sister City Partnership, celebrating 14 years, provides a rich and diverse platform for business, cultural institutions, and artists to interact and develop more robust the transatlantic ties with tremendous support from the Consulate General of Switzerland. This relationship will become a main business platform for the City of Chicago under World Chicago

The Strong Swiss-Midwest business relationship

- Switzerland is the second largest investor in the U.S. manufacturing sector, with a large portion within the Swiss Consular district of Chicago, including Illinois, Michigan and Ohio;
- Swiss companies are the fourth largest foreign employer in the Midwest, an important center of manufacturing, assembly and sales/distribution of Swiss companies and their local partners;

By coordinating Swiss community initiatives, by providing a strong platform for exchanges, and by building and maintaining crucial relationships in political, business and cultural circles, the Consul General of Switzerland remains vital to the vibrancy of the 3rd largest city in the US. Chicago is one of the (if not the) major meeting points of Swiss and U.S. manufacturing, the most important element of both economies, and the Consul General has been a central figure in the efforts to "connect the dots" on many levels. The loss of the Consulate General would be detrimental to Switzerland's footprint in the region and weaken the strong, strategic bonds that have been built over decades.

For these reasons, it is our strong opinion that the Consul General of Switzerland in Chicago plays a critical supporting role in officially representing Swiss interests in the Chicago area and throughout the Midwest. The Swiss American Business Council, along with the Consulate General of Switzerland has solely, without support from any other entity, forged numerous economic relationships beneficial to Swiss business interest and the loss of the Consulate General may impair continued Swiss business support from these relationships in the future.

Furthermore, from a political perspective, a closure of the Consulate General would have severe implications. Chicago is home to President Barak Obama, Senator Dick Durbin, Governor Pat Quinn and Mayor Rahm Emanuel, all of whom have been supportive of Swiss causes, and these intangibles are critical to productive relationships from local, regional and transatlantic perspectives.

We urge you to reconsider the decision to close the Consulate General of Switzerland in Chicago and find an alternate arrangement that would allow an official representation led by a Consul General to remain in place in order to continue to forge, strengthen, and grow the critical relationships for the Swiss-American partnership for the benefit of Switzerland and the US Midwest.



Dear Mr. Kouidri,

Many thanks for your letter of 10 June 2012. It was with great interest that I took note of your arguments, and I can well understand your concerns. The economic ties between Switzerland and the US Midwest are indeed impressive.

The imminent closing of the Swiss Consulate General in Chicago is a result of the substantial budget cuts imposed by the Swiss Parliament. Within the scope of these requirements, the Federal Department of Foreign Affairs FDFA was mandated to reduce the budget earmarked for its network of foreign representations by CHF 30 million. Subsequently, our Department worked out a good number of cost-saving measures that took into account a certain geographic repartition, thus obliging us to include our network of representations in North America.

In the USA, these measures concern the Consulate General in Chicago in particular. For one thing, this decision takes into consideration the fact that the Northeastern USA will continue to be well covered with its needs being met by our other representations in Washington and New York, along with the Swiss House for Advanced Research and Education/swissnex office in Boston. Furthermore, it takes into account the comparatively smaller number of registered Swiss living abroad in the area, as well as the equally lower number of consular items of business and visa applications.

The Federal Council approved the series of budget-cut measures formulated by the FDFA at the end of April 2012 and disposes of no leeway to come back on this decision. The FDFA is naturally making every effort to design the implementation of this decision in such a way as to reduce to the degree possible the consequential impact it will have locally. Hence, in the future, our representations in Washington and New York will be making every endeavor to ensure an adequate official representation of Swiss interests and the maintenance of contact with economic actors from the Midwest. In addition, the FDFA is seeking a solution to the problem of issuing Schengen visas in the

region through the offices of a third-party State. Here too, in the future a Swiss Honorary Consul should be able to provide local support.

Austerity measures always represent a decision that involves weighing pros and cons, making tradeoffs in order to make the best possible use of limited resources. I am well aware of the fact that closing a representation is a radical step, replete with consequences for all involved; however, I do hope that this decision will be easier for you to understand on the basis of these explanations.

Dear Mr Kouidri,

Thank you for your letter of 30 October 2012; your views regarding the closure of the Consulate General in Chicago captured my full attention.

The Council of States Foreign Affairs Committee closely monitors developments in Switzerland's network of representations abroad; it is regularly updated on the opening and closure of Swiss embassies and consulates, as well as on the strategy applied in that area by the Federal Council.

The decision to close the Consulate General in Chicago gave rise to a number of reactions among the Swiss community of Illinois. I would therefore like to inform you that the Council of States Foreign Affairs Committee will, in the next few weeks, study a petition submitted by the Swiss Club of Chicago asking the Federal Council to reconsider its decision to close the Consulate General in Chicago.

The Swiss Club of Chicago is extremely concerned by the Federal Council's decision, and the Committee will study the petition with the attention and care that it deserves. The decision of the Committee will be published on the Parliament website (www.parlement.ch) in due course.

On behalf of the members of the Swiss-American Business Council (SABC), I thank you and your committee for the diligent consideration of the petitions and for voting on Jan 15, 2013 to reverse the closure order of the Consulate General of Switzerland in Chicago. We believe this was a wise decision that will protect Switzerland's important commercial, cultural and consular interests in this key region of the United States.

We understand that there are several more steps ahead in the process to keep the Consulate General open here in Chicago, and we offer our full support to making this happen.

As we have previously stated, the US Midwest is an important economic engine and is the largest manufacturing region in the U.S. (and one of the top regions globally). Many Swiss companies have recognized these facts and have positioned themselves here to benefit from this region. As President Obama stated in the State of the Union address last night, the re-emerging U.S. manufacturer sector is a top priority of his administration's second term, and this is expected to directly benefit Swiss companies positioned in this region and who are themselves experts in manufacturing. As a side note, our organization has been proud to promote the Swiss apprenticeship program as a successful model for manufacturers in the Midwest, and this model forms a key piece of President Obama's initiative to educate students for manufacturing jobs.

With the strong presence that the Consulate General of Switzerland provides in the Midwest, Swiss business will be able to benefit from the new manufacturing efforts and initiatives. It would be a serious mistake for the Government of Switzerland to abandon this region at a time when a major revival of manufacturing is under way, with clear benefits for Swiss business.

We will inform our constituents, including Swiss companies in the Midwest and in Switzerland, about the positive step taken by your committee and await the further outcome of the discussions in the Staenderat later this month.
